The UMKC Oxford program is designed for practicing attorneys, judges, clerks and their families and companions. Attendance at the program is not limited to legal professionals. Anyone with an interest in the British legal system may attend. Traveling companions of the seminar attendees are welcome! The two-week summer program examines both the similarities and the differences of the British and America legal systems with a principally British faculty. More importantly, while learning you will have :

Several social functions are included in the program. Organized groups visit William Shakespeare's Stratford-upon Avon and London's legal district. On-site assistance is available from our staff member who travels with the group. Breakfast is provided every day and lunch is provided on seminar days. Best of all is a five-day weekend situated in the middle of the program allowing participants to enjoy several days off with no scheduled activities. Many participants take advantage of the break to further explore London, the Cotswolds, Scotland, Wales, Ireland or the continent.

The course is presented at St. Edmund Hall, the only historic "hall" still remaining in the Oxford University system. Participants in the program experience the historic surroundings and a central location. St. Edmund Hall is within walking distance to the ancient city of Oxford, the Crown Courts, other colleges, the main bus and rail transportation routes, Oxford's downtown shopping district and many fine restaurants.
